1	The total number of sections of the school shall be restricted to 36 of which not more than 1/3rd sections may be used for senior secondary classes and further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation by law subject to availability of class rooms of greater than 500 ft dimension.
